IMPORTANT NEWS REGARDING YOUR WEA SELECT DENTAL PLAN!

Starting this year, your benefits will renew on November 1st

Currently, your plan's annual benefit maximum is reset on October 1st of each year. This year, your annual benefit maximum renewal will be extended one month (through October 31st) so it will coincide with the plan year change to November 1st.

To help offset this, you will receive an additional \$170 (approximately 1/12th of the annual benefit maximum) credited toward your annual benefit maximum on October 1, 2013. This "extra" benefit will be in addition to any annual benefit maximum you still have remaining for the 2012-13 benefit year.

If you are planning to have major dental work done, you may want to schedule your visit after November 1st to take advantage of your new 2013-14 annual benefit maximum.

Going forward, your annual benefit maximum will renew every year on November 1st.

ACCESSING CARE

Explanation of Incentive plan

The Delta Dental Incentive plan is designed to promote regular dental care by increasing the amount paid for preventive care and regular visits from one 12-month benefit period to the next. During the first benefit period, the payment level for covered and allowable Class I and Class II benefits is 70 percent. This payment level increases by 10 percent — up to a maximum of 100 percent — each successive benefit period in which benefits are used at least once by the eligible person(s). If the once-a-year visit is missed, the payment level will be decreased by 10 percent for each benefit period during which benefits are not used. In no event will the payment level be less than 70 percent. The incentive provision described above does not apply to Class III benefits, which are paid at 50 percent.

If you are transferring your benefits from another school district that used the WEA Select Dental Plan, your incentive level will transfer with you! You will need to complete the "Incentive Level Transfer Information" section of the enrollment form and have it submitted to Washington Dental Service.

How to use your Delta Dental Incentive plan

You may select any licensed dentist under this plan; however, if you choose a participating Washington Dental Service dentist, your out-of-pocket expenses may be lower. Washington Dental Service will handle all customer service and claims processing for your plan. Tell your dentist you are covered by Washington Dental Service and give him/her your member identification number, the plan name and group number.

Delta Dental Premier and Delta Dental PPO dentists

If your dentist is a Delta Dental Premier or Delta Dental PPO participating dentist, he or she will submit your claims directly to Washington Dental Service. Participating dentists receive payment based upon their pre-approved fees with Delta Dental. They cannot charge you more than these fees. You are responsible only for your stated deductibles, co-insurance and/or amounts in excess of the plan maximums.

Your benefit dollars will go further if you seek services from a Delta Dental PPO dentist. Delta Dental PPO dentists provide the same high level of care as Delta Dental Premier® dentists, but they have agreed to a lower average fee schedule.

Delta Dental Premier dentists are members of our traditional fee-for-service plan, but they are not part of the PPO network.

Additionally, if you visit a Delta Dental PPO dentist, you will be able to take advantage of a higher annual plan maximum. Your dental benefit plan maximum will increase to \$2,000 if you select a Delta Dental PPO dentist!

Finding a dentist

You can find a participating dentist in your area by visiting the WEA landing page at the Washington Dental Service web site at www.DeltaDentalWA.com/WEA, and go to the "Find a Dentist" section. **Be sure to select the appropriate plan – Delta Dental PPO or Delta Dental Premier – and follow the prompts.**

Nonparticipating dentists

You are not limited to using a Washington Dental Service dentist. If you choose a nonparticipating dentist, you will be responsible for having the dentist complete and sign claim forms. It will also be up to you to ensure that the claims are sent to Washington Dental Service. Claim payments will be based on actual charges or Washington Dental Service's maximum allowable fees for nonparticipating dentists, whichever is less.

Predetermination (estimate) of benefits

We recommend that you ask your dentist to complete and submit a standard WDS claim form for a predetermination of benefits if you are considering extensive treatment (such as crowns, oral surgery, periodontics and prosthodontics). This will allow you to know in advance what procedures may be covered, the amount Washington Dental Service may pay and your expected financial responsibility. A predetermination of benefits is not a guarantee of payment.
